Workshop Concept

During each session, participants will discuss on 3 stations (30 min each) with an experienced gastroenterologist and a surgeon the most important information on a clinical finding or treatment to improve patient care and to better collaborate with surgeons. Each station covers a different topic, and all discussions are case-based and illustrated with videos and/or images.

- The information the surgeon needs to decide on the treatment plan.
- The rationale of surgical decision-making.
